

AMENDMENT POLICY

An amendment fees shall be charged at USD50 per passenger for any of the following amendments after the acceptance of bookings by SCASIA Sdn Bhd:-

- Change of Passenger Name
- Swapping passenger / rooming list
- Downgrading of Cabins

Note:

- Amendment fees are applicable for amendments requested at any time.
- No charge shall be levied for the Upgrading of Cabins.
- Prevailing rates will be applicable for change of departure and additional cabin.
- Split of cabin; the new cabin will be considered as new booking at prevailing rates.
- Add on passengers in the same cabin will be charged at prevailing rates.
- Change of all passengers in the original cabin will be treated as cancellation and prevailing rates will be applied.

CANCELLATION CHARGES

1. Notification to cancel Salsa Cruise bookings must be made in writing to SCASIA Sdn Bhd and shall be effective only upon actual receipt by SCASIA Sdn Bhd.
2. The cancellation policy of Salsa Cruise Asia apply as follows :-

27 th November 2008 – 31 st January 2009	40% of Full Fare
1 st February – 30 th April 2009	60% of Full Fare
1 st May – 31 st July 2009	80% of Full Fare
1 st August 2009 till event date / No Show / No Written Notice	100% of Full Fare

VISA REQUIREMENT

It is the responsibility of the participant to ensure that VISA requirements are complied with. We can provide you with full details if you are unsure of them. **SCASIA Sdn Bhd has the rights to refuse passenger boarding if the necessary entry visas are not in order. In the circumstances, this will be treated as No Shows and a 100% cancellation charge will be levied.**

VALIDITY OF PRICES

- Prices for Salsa Cruise Asia are subject to availability and conditions. The prices are not guaranteed and are subject to change without prior notice.
- Any featured prices for a cruise or for accommodation or any other package will normally be based on a minimum of two adults sharing, unless otherwise indicated.
- Featured prices may be subject to port, plus government charges. Please ensure you are aware if such charges are included in your particular cruise. Fuel Surcharge and Passenger Handling Charges are subject to change without prior notice.

Deposits/Final Payments

- A deposit is required to confirm a reservation. Deposit amount will be determined at time of booking. Deposit made is non-refundable.
- Full payment will be required for those who made a deposit within the period of the packaged confirmed and invoice will be send 2 weeks before the due date to settle the full payment. If you are not able to pay the balance of your booking within the due date you will be re-invoiced for the new price for the new period. The price of any travel related service is never guaranteed until the final balance has been paid and the documents have been issued. SCASIA Sdn Bhd cannot take responsibility for any price increase that may be notified, at any time, by the travel provider.

CRUISE, EVENT DATE, LOCATION AND ITINERARY

SCASIA Sdn Bhd reserves the right to change the cruise, the dates of the event, the location and the itinerary of the event by giving advance notice to the participants via email or mail. Participants may cancel Salsa Cruise bookings by paying the relevant cancellation charges.

GOVERNING LAW AND JURISDICTION

The terms and conditions herein shall be governed by and construed in accordance with the laws of Malaysia and you agree to submit to the jurisdiction of the courts of Malaysia.

TRAVEL POLICY

- Passage for pregnant women will only be permitted before their 24th week of pregnancy and a doctor's certificate stating that they are fit to travel must be provided.
- All valid passports must have at least 6 months validity from the actual date of sailing.
- Strictly no refund will be made when customers are denied embarkation for non-compliance of the above Immigration requirements.
- A booking may only be made by a person aged 18 or over. All Passengers who, at the time of departure, will be under 18 years of age must be accompanied by a Passenger aged 21 or over who will at all times during the cruise be responsible for their welfare, conduct and behavior.

FORCE MAJEURE

- **SCASIA Sdn Bhd** shall not be liable for any compensation where the performance or prompt performance of its contractual obligations is prevented or affected or you otherwise suffer any damage or loss as a result of a force majeure.
- "Force majeure" means any event beyond SCASIA Sdn Bhd's control. Such events include but are not limited to war, threat of war, riots, civil strife, actual or threatened terrorist activity, epidemic or health risk, industrial dispute, natural/nuclear disasters, fire, technical problems, port closure, adverse weather conditions and failure or negligence on the part of the cruise operator.
- Except for warranties expressly provided by SCASIA Sdn Bhd in writing, all warranties implied by law including but not limited to satisfactory quality or fitness for purpose are hereby excluded.
- SCASIA Sdn Bhd shall not be liable for any personal injury or loss or injury to property, indirect and consequential damages or loss of profit.

SECURITY SAFETY AND SUPPORT

Passengers are expected at all times to conduct themselves in a proper manner and with due regard to the health, safety, comfort, enjoyment and general well-being of all persons both on board the cruise ship and involved in the provision of any service or facility forming part of the cruise or any shore excursion, and the Passenger expressly agrees to this. If it appears that a Passenger's conduct, behaviour or health is such as to be a breach of this requirement or the Passenger's behaviour, health or conduct is likely to endanger the Passenger's own health or safety or that of any other Passenger or crew or may make the Passenger likely to be refused permission to go ashore at any port or may make **SCASIA Sdn Bhd** liable for the costs of any medical treatment and/or maintenance and support and/or repatriation, then **SCASIA Sdn Bhd** and/or the Master shall have the right according to the particular circumstances to take any one or more of the following measures as may appear to be reasonable and appropriate –

- refuse to embark or to disembark the Passenger at any particular port or other place of call;
- disembark the Passenger;
- transfer the Passenger to another berth;
- confine the Passenger to a particular stateroom or to the ship's medical centre;
- through the ship's doctor and/or his staff, administer any drug, medicine or other substance of a similar nature, or admit and/or confine the Passenger to a hospital or any similar institution at any port as the ship's doctor may consider necessary.

BAGGAGE, VALUABLES AND OTHER POSSESSIONS

Dangerous or illegal articles such as weapons, explosives, oxygen, combustible substances or non-prescription controlled substances may not be brought on board the ship. Any such items shall be surrendered to the Master of the vessel at embarkation, and may be disposed of at the sole discretion of the Master. You should retain valuables such as cash, negotiable securities or other financial instruments, gold, silverware, jewelry, ornaments, works of art, photographic/video/audio equipment or supplies, laptop computers, cellular phones or other valuables in your personal control as **SCASIA Sdn Bhd** is not responsible for damage to or loss of these items.

CRUISE & EVENT HEALTH CONSIDERATIONS

By joining the Salsa Cruise Asia event and boarding the Cruise ship Guests represent themselves as physically and otherwise fit to travel. If you have a medical condition which requires you to take prescription medication or may require you to obtain medical care during the course of your cruise vacation, please consult with your personal physician prior to traveling. For your convenience, a physician and nurse are on call 24 hours a day to provide basic medical services. The physician and nurse are not employees or representatives of **SCASIA Sdn Bhd** and will charge their prevailing fees for services provided at your request. Decisions regarding medical care and treatment are personal and confidential and as such are strictly between the Guest and physician and nurse. **SCASIA Sdn Bhd** is not liable for any death, personal injury, illness or emotional distress caused by reason of any treatment, diagnosis, advice, examination, prescription or other service provided by such medical personnel or by the failure of such medical personnel to provide any treatment, diagnosis, advice, examination, prescription or other service. The ship's Master has the right at any time to require any Guest to disembark for medical reasons, and compliance is mandatory. For your peace of mind, we recommend that the guest is covered by their own Travel Insurance.

CRUISE OPERATOR TERMS AND CONDITIONS

You acknowledge that SCASIA Sdn Bhd is not the Cruise operator and by joining the Salsa Cruise Asia event and boarding the Cruise ship you hereby unconditionally agree to release SCASIA Sdn Bhd from any liability, damages, losses and cost arising directly or indirectly from the failure or negligence of the Cruise operator, its servants and agents.
